### Purpose and Goals

 BCSH will be reorganized into two agencies focused on improving state housing policy, consumer protection, and service delivery:

- California Housing and Homelessness Agency (CHHA): Dedicated to addressing the full spectrum of California's housing needs.
- Business and Consumer Services Agency (BCSA): Dedicated to providing effective and efficient regulation and focused consumer protection

## **Advancing Housing Solutions**

To create a California where residents have access to safe, dignified, and affordable housing. By focusing on the full spectrum of housing needs - from preventing homelessness, to producing low-income housing, to promoting homeownership. CHHA will also be responsible for advancing civil rights laws and protections, including efforts to equal employment protections.

### **Key Objectives:**

- Streamlined Funding and Compliance
- Accelerating Progress Toward CA's Housing Goals

## Maintaining Existing Connections

- CHHA and BCSA will maintain and expand existing partnerships in all areas related to consumer protections and housing including ongoing work at the Department of Financial Protections and Innovation and the Department of Real Estate.
- CHHA will also maintain and expand existing partnerships as they relate to transportation, climate, housing.

### Role of HCD

- Focus on the administration of government-to-government financing.
- Existing divisions within HCD will remain unchanged:
  - Federal financial assistance
  - Policy, planning, accountability
  - Fair housing
  - Codes and Standards
- NOFA calendar is unchanged.

### Housing Development and Finance Committee (HDFC)

# Executive Committee (Board, comprised of Secretary, HCD Director, CalHFA Executive Director)

- Overseeing One Stop Shop and aligning programs and funding opportunities across state government.
- Approving program guidelines and awards in public meetings.
- Oversight for multifamily affordable housing programs administered by the Committee.
- Streamlining asset management for affordable housing developments.

## Housing Development and Finance Committee

### **Committee Staff:**

- Day to day work of the committee including:
  - Making award recommendations.
  - Consolidating programs coming from HCD and overseeing phased transfer.
  - Administering aligned asset management.

## Phasing of transition

### FY 25-26

- Development of single application and award process (sources administered by Committee).
  - Solicit input from all impacted entities: HCD, TCAC, CDLAC, CalHFA, nonprofits, forprofits, tribal governments, local governments.
- Recommendations for streamlining compliance monitoring
- Recommendations due July 2026 on funding application and alignment.

### FY 26-27:

- CHHA is stood up, BCSH is dissolved.
- Programs are transferred over from HCD upon appropriation and subject to the budget.

### Additional changes

### FY 25-26:

 Mandated collaboration between CHHA and CHHS to align funding, policies, and data to achieve goals of Statewide Housing Plan and Action Plan to End and Prevent Homelessness.

### FY 26-27:

ICH becomes an independent business unit within CHHA.
