Agenda Item III: Adoption of Changes to the Homeless Coordinating and Financing Council Governance Guidelines

At its January 10, 2018 meeting, the Homeless Coordinating and Financing Council (Council) adopted governance recommendations put forward by the Council Governance Subcommittee. Senate Bill 850 (Health and Safety Code Section 8257), passed in June 2018, made several important changes to the Council, including moving the Council from the Department of Housing and Community Development to the Business, Consumer Services and Housing Agency, providing dedicated staff, and providing new statutory guidance as to the Council's purpose and goals. Given these changes, the governance guideline summarized below needs to be updated.

Recommendation: Rather than adopt any changes to the current governance guidelines at the October 9 Council meeting, staff recommends convening the Council Governance Subcommittee to provide recommendations for updating the current governance guidelines. These recommendations would be presented at the Council's January 2019 meeting.

Current Governance Guideline Status i. Health and Safety Code Section 8257 designated i. Ben Metcalf, Director of the Department of Housing and Community Development (HCD), the Secretary of the Business, Consumer was elected as the Council Chair and Russell Services and Housing Agency (BCSH) as Chair of Atterberry, Undersecretary of the Department the Council. - meeting, the Council shall elect the Chair and Chair-elect, Vice Chair and Vice Chair-elect, to assure continuity in the succeeding year. In the year where the Chair is not a state representative, the Vice-Chair shall be a state agency or department representative appointed to the Council.
- ii. As noted above, Secretary Podesta is now serving as Chair of the Council. The Council needs to elect a Vice Chair and Vice Chair-elect to serve in calendar year 2019. The Council needs to update this governance provision to reflect the changes made by Health and Safety Code Section 8257.
