Sacramento – The Homeless Coordinating and Financing Council (HCFC) has a new Executive Officer and a new Grant Manager.

Ginny Puddefoot of Davis has been named Executive Director of HCFC. Puddefoot has been an Assistant Deputy Director in the California Department of Housing and Community Development's Division of Financial Assistance since 2017. The Homeless Coordinating and Financing Council was created in 2017 to oversee the implementation of "Housing First" policies, guidelines and regulations to reduce the prevalence and duration of homelessness in California. On July 1, 2018 the council was expanded and moved to the Business, Consumer Services and Housing Agency, and provided with staff to evaluate grant proposals. Currently, the council is working to provide \$500 million in one-time funding for emergency aid to enable local governments to respond to homelessness.
